## RULES and REGULATIONS

The overall premise for the Rules and Regulations is to create an environment where everyone can enjoy himself or herself. The abuse or non-conformity to the Rules and Regulations can and will result in the suspension and/or termination of privileges.

- **ALL** players are required to check in at the Golf Shop before every round of golf and must present sales receipt to Outside Services staff.
- 4 (Four) players and 2 (two) carts maximum per group. Riders are required to pay for their seat on carts if available.
- Private Coolers are not allowed; all food and beverages must be purchased from Woodhaven Country Club or Mulligan's.
- All players must wear proper golf attire; no tank tops, t-shirts, denim, swimwear, etc. This applies to riders and those using the practice facilities as well.
- Players must have their own bag and set of clubs. Rental sets are available from the Golf Shop.
- Golf Cart Rental Agreements must be signed for usage.
- Please keep golf carts on paths around tees and greens and/or at least 30 yards away. Please do not go past cart signs and directional ropes.
- Please fix your ball marks on the green and repair divots.
- Please fill divots with sand & seed mix supplied on each golf cart.
- All Members, Homeowners, and Guests will treat all employees with respect, the consequence of this may result in suspension.
- Any issues with an employee of Woodhaven Country Club shall be reported to the Department Head.
